- § Patrick will provide the powerpoint to Nick for inclusion in the Select Board package by Friday, August 26.

- § Patrick will be the sole presenter.

- § The Select Board will be asked to approve the CCA Plan for submission to DPU.

- Note: Medfield's CCA program is named "MCE" for Medfield Community Electricity.

- With Select Board approval of the Plan:

- § First: DPU will provide a Public Hearing date/time expected to occur sometime in October 2022

- Ø Information relevant to the Public Hearing will be published in one or more local papers by DPU. The CCA subcommittee will be responsible to publish this information on the Town Website and/or on [electricity.medfield.net](http://electricity.medfield.net) as appropriate.

- Ø At the Public Hearing, DPU and, optionally, the Medfield CCA subcommittee will make statements relevant to the Plan, and Medfield community participants in attendance will be invited to make statements. No dialog will be engaged.

- § Second: DPU may make requests for further information from the Town, after which DPU will ultimately issue an 'order' (...approved conditional upon) and finally a compliance filing. Several months may elapse during this stage of the DPU review.

- § Third: The bid seeking stage may begin, detail to be developed as the timeframe nears. It is hoped that this stage may commence in Q1 2023. We noted the importance of being pro-active with developing outreach materials as the bidding stage approaches.

- Next meeting (assuming Select Board approval on August 30) will be scheduled when DPU provides us with a Public Hearing date/time.
