The proposed revisions would amend both Section 300-14.10(H)(2)(d) and Section 300-13.8(C)(2) to allow home occupation signs up to 4 square feet in total area when applied to a surface, or 2 square feet per side when displayed on a freestanding sign.

- **7:30 pm: R.K. Medfield, LLC (owner/applicant), 230 Main St (site also known as “Shaw’s Plaza”),** seeks a Site Plan Approval for the project known as “Chase Bank.” The proposed project includes the construction of a new 3,293 SF +/- building on the site, as well as associated sidewalks, landscaped areas, and stormwater management components, and utilities. Minor parking modifications to include ADA parking are also proposed. The property is located at 230 Main Street (at the Shaws Plaza which is the subject of Site Plan Approvals from January 29, 1979, November 23, 1987, and August 15, 2022) in the B Zoning District with Partial Secondary Aquifer Overlay and is shown on Assessors' map 51 as lot 058. Plans are available on the Planning Boards webpage on the Town’s website. **This is a continuance from 11/17/25, 12/15/25, and 01/12/25***
