*Brief summary/explanation of the petitioned article:*

The current minimum parking requirement for assisted living facilities in the Medfield State Hospital Historic District is 0.41 spaces per unit. This value is much lower than a requirement found to be inadequate by the Medfield ZBA for a facility well-served by public transportation (0.58). The article proposes 0.82 spaces per unit, to preserve public safety by ensuring that vehicles won't block emergency vehicles.

## VOTER PETITIONED ARTICLE FOR TOWN MEETING

To the Board of Selectmen:

We, the undersigned voters of the Town of Medfield, hereby petition the Board of Selectmen pursuant to MGL Chapter 39, Section 10, to insert the following article in the Warrant for the  Annual  Special Town Meeting to be held on May 4, 2020

To see if the Town will vote to:

Amend Table 2 in Article 300-20. "Medfield State Hospital District" to adjust the minimum parking requirement for Assisted Living Facilities from 0.41 to 0.82 spaces per unit. The current requirement is inadequate for the large number of employees, visitors, residents, physical therapists and others serving the residents, and will lead to vehicles blocking access of emergency vehicles. The Medfield ZBA found that a figure of 0.58 was inadequate for a facility that is well-served by public transportation. A requirement of 0.82 spaces per unit would address this issue.
