We had 456 respondents to an online survey, over 30 leadership interviews 130 high school students participated. We interviewed men and women on the street and had up to date 11 master plan, committee meetings. And then things changed.

COVID-19 hit devastating individuals, families, communities, indeed the entire planet. So in the meantime, we're adapting short term. So you see here a creative solution to restaurant dining in Amsterdam on the left, and a creative solution to returning to school in China on the right. The children were asked to make their own hats with approval. Distance wings. Corona also has created some opportunities, municipalities are reimagining their downtown's closing streets for outdoor seating. For example, reallocating paved space for pedestrians and bicyclists in some of these municipalities have already announced that these changes will be permanent, that they tried them out or are in the process of trying them out, piloting them with a goal to make them permanent. Twitter and Facebook have already announced that work from home policies are going to be permanent post COVID, even after the vaccine. And prior to COVID-19. Boston was apparently behind other cities and the number of companies with work from home policies that for knowledge based economies, and in fact significantly

so in the meantime, Transportation Secretary Stephanie Pollock from the state MBTA General Manager governor Baker in his office and area employers, the large area employers have formed a task force to talk about an organized approach to establishing work from home policies and staggered schedules. And then what we call ripe apples, low hanging fruit, things that are relatively easy, low cost actions that make a difference that you can do in the beginning to keep the momentum going. And the plan at the implementation plan will identify responsible parties, existing resources, potential partners, and, if possible, any kind of funding or budgeting information.
