Brief summary/explanation of the petitioned article:

1. Medfield Public School policy states that the Town Moderator is responsible for appointing members to the School Building Committee (as was past practice with the last two MSBA-funded school building projects), and the SBC then oversees all school projects.
2. The Medfield Permanent Building and Planning Committee bylaw does not specify which public body or town officer is responsible for appointing its members, nor does it explicitly state its role with regard to school projects (regardless of MSBA funding).
3. A bylaw committee is needed to reconcile Medfield School Committee policy and Town of Medfield bylaws respectively, and to ensure diverse community engagement in the school building process.
