Why Solar?

- Key element of the town's Climate Action Plan
- Reduce GHG emissions
- Offset Price of Electricity
- Take advantage of incentives
- Produce electricity locally

Why Solar Now?

*The best time to get solar was
10 years ago.*

The next best time is now.

- Accelerate the town's decarbonization
- Emissions savings accrue year after year
- Interconnection Limits
- Take advantage of current state incentives

Why Schools?

- Current installations are at Wastewater treatment plant (2015) Public Safety Building (2016) DPW Building (2023)
- Energy Committee & Town Energy Consultant inventoried potential new solar locations in town
- Schools have care & custody of the areas with largest potential for solar.

The parking lot canopies and new Blake roof section were identified as the best locations to move forward now

Project Overview

- Arrays at High, Memorial & Blake Schools & Blake roof portion
- Three separate projects
- Power Purchase Agreement
- No capital investment by the town or schools
- Fixed electricity supply rate for 25 years
- DPW roof is also a PPA

Project Benefits


- Help Medfield reach its Climate Goal by reducing GHG emissions
- Will provide 76% of electricity for use by High, Middle & Memorial Schools
- Begin generating electricity for the schools ASAP
- Stabilizes future energy expenses
- Accesses current incentive programs and interconnection capacity, which are limited
- Visible reminder the schools intend to be part of the climate solution



PPA rates assume a 30% tax credit. Subject to final engineering, utility approval and incentive award.

- May 2023 – town meeting, Article 26 - Approved
- **June 2023 - Renderings - share with community**
- June 2023 - Incentives finalized/updated pricing (still getting guidance on tax incentives)
- Contract negotiations/contract language/School Committee decision
- Goal to begin work when school ends in June 2024




