I understand the Wheelock site has operational and construction cost efficiencies, but LOCATION is the #1 factor for the people of Medfield. Better to forego state funding and spend the money to keep it at Dale. Don't make the same mistake again the new plan MUST be at Dale St site.

Give the school district the flexibility to build smart with an eye towards the future. I recommend the SBC work with the school committee to communicate its vision for all of the buildings in the district with assumptions about what is likely to happen over the life of this new Dale St replacement school. That view may help the voters understand better why the building should be located in a specific site and/or be of a certain size.

1. My primary concern is reducing the transitions between buildings for elementary-age children. The current elementary configuration negatively impacts learning by disrupting continuity of programming. Additionally, these frequent building transitions take a toll on many children and are a negative about the current elementary school structure in the town. I support reconfiguring the grades as a part of the project to reduce the transitions or moving to a campus model with more consistency between buildings. The best approach would be to plan to build a 3-grade school and eliminate one of the elementary buildings with another renovation. Wheelock is due for a renovation and could be expanded (or eliminated after another building is built). This makes the Wheelock site ideal for the new building because the Dale site is not ideal for a three grade school (unless it involved expanding Memorial School. Additionally, the term construction impact is a vague term. I AM concerned about educational impact of a construction project would oppose any proposals that would disrupt the learning environment for students. This would include renovating an existing building while trying to hold school, displacing students/grades into other schools during renovation, etc.
