Capital Project Prioritization: Potential Criteria

Tier 1 - "Must do"

Public health/safety needs
Regulatory requirements
Legal obligations (including lease payments)
Alleviate/prevent service disruptions

Tier 2 - "Should do"

Rehabilitates obsolete assets
Address assets at end of life cycle
Reduces future investment/maintenance needs
Leverages state/federal grant funds (matching funds, etc.)

Tier 3 - "Could do"

Provides new or expanded services
