



## TOWN ADMINISTRATOR REPORT

Tuesday, September 17, 2024

### Town House

- I have been asked to lead a roundtable discussion at the Massachusetts Municipal Managers Association Boot Camp on September 18th.
- Frank Gervasio has been asked to speak at the MA Association of Town Finance Committees (ATFC) Annual meeting to present the Budgeting 101 session.
- The MA Department of Public Health has notified us that COVID-19 tests will be available to the Town for distribution.
- It is EPA Septic Week! In partnership with the Neponset River Watershed Association, the Town will participate in a social media campaign to raise awareness of septic systems' effects on the environment.
- The Town House in collaboration with TSARC will participate in the Black Earth Composting Program.

### Water and Sewer Rates

- The Board of Water and Sewerage held a public hearing on Monday, September 10, 2024. The board voted for a 5% increase to water rates and a 4% increase to sewer rates.

### Land Use Department

- Land Use Director, [Maria De La Fuent](#) hosted the Three River Interlocal Council (MAPC) at the Medfield State Hospital/Bellforge Arts Center for their monthly meeting.

1. Option Giving Harding St. the ROW (validate this is not a beneficial option)
2. Option Giving Hospital Rd. the ROW
