


Assistant to the Town Administrator

Medfield Outreach

- Town Administrator, Kristine Trierweiler, Assistant Town Administrator, Brittney Franklin, Human Service Director, Kathy McDonald and Medfield Outreach Clinician, Mia Cianciarulo were excited to attend this year's Wilkins Glen Annual Block Party. We were able to bring backpacks from our School Supply Program to share with families, helping students get ready to start school.

Facilities Department

- The Metacomet Tennis courts reconstruction project commenced early July, and is now in the final stages. The court surfacing for these asphalt tennis courts started this week, and courts are expected to be open for play before the end of September.
- Fifteen new exterior windows were recently installed at the Town House. The majority of this project was funded through the Department of Energy's: Energy Efficiency and Conservation Block Grant (EECBG). Window replacements are expensive, and this grant provided an opportunity to have a portion of the Town House's 25+ year old windows replaced. The new windows will improve energy efficiency and occupant comfort at the Town House.
- The salt shed building at the DPW is in the process of being repainted. The existing paint was faded and flaking off, leaving the structure exposed to the elements. The shed has been power washed, scraped down, primed, and will receive two finish coats of paint which will improve the overall lifecycle of the structure. The project is expected to be completed within the week.



Fire Department



- On July 29th, the Medfield Fire Department held a swearing-in and promotion ceremony at the public safety building. The event recognized six new full-time firefighters—Nick Novitch, Collin Hern, Bret Matthews, Mike Murphy, Pat Dunn, and Caroline Conlin—who officially took their oaths of service to the Town of Medfield. In addition, Scott Donahue was promoted to the rank of Captain, honoring his two decades of dedicated service and leadership within the department. Friends, family, and community members attended the ceremony, where each firefighter was pinned either by the Fire Chief or a family member.
- Looking ahead, the department will be hosting its **annual Fire Department Open House on Saturday, October 4th**. All families are welcome to attend this community event to learn more about the fire service, meet members of the department, explore the fire trucks, ambulances, and other emergency equipment. More details will be shared in the coming weeks.

Trinity Financial Update

- Trinity has completed several permitting milestones in the last month, receiving its Stormwater/Drainage compliance approval from the Board of Health, its Definitive Subdivision and Site Plan approval from the Planning Board and approval from the Conservation Commission for the proposed off-site infrastructure improvements. Trinity will be preparing documentation for submission of its Single Environmental Impact Report to MEPA in the coming weeks. Trinity will be preparing documentation to go out to public bid for the construction of the offsite intersection improvements in the early fall.
