Re: Capital Requests/Changes FY27-31

Dear Mrs. Trierweiler,

Please note the following updates to our projected Capital Requests for FY27–FY31:

- The AED replacement request for FY30 has been removed, as new units were purchased last year through grant funding. These units have a projected lifecycle of 8–10 years.
- The radio system communications upgrade has been removed. Based on current maintenance costs, an upgrade is not cost-effective at this time and, if needed, would be more appropriately requested through IT or Facilities.
- Current requests now reflect only the routine fleet replacement schedule. Our department fleet operates three 2020 line cruisers, and we propose replacing one per year over the next three years, extending each vehicle's lifecycle to 7–10 years.

Description:

This request is for the purchase of one fully equipped police cruiser to replace an aging vehicle in the current fleet. The new cruiser will be used for routine patrol, emergency response, and community policing. It will be outfitted with standard law enforcement equipment including emergency lighting, radio and computer systems, safety partitions, speed detection systems (radar capable of oncoming and rear approaching vehicle speeds), and vehicle graphics. 2026 Chevrolet Tahoe PPV (Patrol Pursuit Vehicle) commonly referred to as a line cruiser.

Benefits of Project and Impact if Not Completed:

The addition of a new police cruiser will maintain operational readiness, ensure timely response and enhance public safety. Replacement helps to avoid high maintenance costs, enhance officer safety and supports community policing efforts by ensuring 24/7 visible patrol and emergency response. The ability to rotate vehicles with sufficient engine rest time will extend the overall lifespan of the fleet. **Negative Impact if Not Acquired** – Failure to fund request will hinder the department's ability to provide efficient and effective law enforcement services. Specifically – Reliability risks related to aging vehicles experiencing mechanical failure causing unplanned downtime and reduced patrol availability; increased maintenance costs; reduced community presence; increased wear on remaining fleet. The loss of a single cruiser puts additional strain on remaining vehicles, accelerating wear with the likelihood of additional mechanical issues.

Alternatives Considered (if any):

Operating Budget Impact:

The ideal timeframe to cycle out a cruiser is 55,000 miles. This allows for the greatest trade-in value and can reduce maintenance expenses that are no longer covered under warranty but likely to occur. If new vehicles are not regularly introduced into the fleet, maintenance costs will increase, trade-in values will decrease and the department will eventually require the purchase of multiple vehicles in a single fiscal year. Vehicle costs and related equipment have increased substantially year to year.
