Description:
The current Assessing (CAMA) software, AssessPro Classic will no longer be supported after FY 2027. We would like to upgrade to the newest cloud base software from Patriot (AP5). The data and programs will be moved from inhouse servers to cloud based servers managed by Catalis (Patriot). The costs include training and historical database transfer along with the new software and hosting. The attached budget is an estimate as it is only good through 2025. The final budget numbers won't be available until December 2025. I am using year #2 as an estimate which was recommened by Catalis. \$1800 is a one time charge for CAI (GIS vendor) to switch over their files and program to work with AP5.

Benefits of Project and Impact if Not Completed:
Current programs will no longer be supported in the near future. New system allows remote access and more protection for our servers.

Alternatives Considered (if any):
None - It is much more cost effective to stay with our current provider. The training is also easier as the staff is already familiar with the product.

Operating Budget Impact:
The Operating budget would increase annually by the upgraded amount included in the quote. Its is approximately an \$8650 (+6% each year) increase to the current software costs, annually. CAI is a one time charge.

PROFESSIONAL GIS SERVICES AGREEMENT FOR THE CITY OF MEDFIELD, MASSACHUSETTS

July 31, 2025

This Agreement made this 31st day of July, 2025 between Cartographic Associates, Inc., doing business as CAI Technologies, a New Hampshire corporation with its office located at 11 Pleasant Street, Littleton, NH 03561, hereinafter called CAI, and the City of Medfield, a municipal corporation located at 459 Main Street, Medfield, MA 02052, hereinafter called the CLIENT, to provide professional GIS services according to the specifications, terms, and conditions below written.

Witnesseth, the above parties agree as follows:

SCOPE OF SERVICES

Redevelop AxisGIS Data Processor for Patriot Assess Pro 5 Database System

- A. CAI shall design and create a Data Processing Utility for the CLIENT to use for periodic upload using an export file(s) from the Patriot Assess Pro 5 CAMA system to an online database accessed by the AxisGIS website.
- B. CAI shall provide remote installation for the redeveloped Patriot Assess Pro 5 AxisGIS Data Processor.

CLIENT RESPONSIBILITIES

- A. The CLIENT shall designate a project liaison who will be CAI's main contact during the course of the project, and who will be responsible for all CLIENT related obligations in this project.
- B. The CLIENT shall provide CAI with an ASCII text or DBF formatted export file from the CLIENT's Patriot Assess Pro 5 CAMA system containing the attribute information for inclusion into the AxisGIS site.
- C. The CLIENT shall develop and provide CAI with the building photos and use a file naming convention established using the system ID.
- D. The CLIENT shall provide and authorize CAI to acquire all necessary information for the successful completion of the project. In order to ensure the project timetable, authorization shall be provided within fifteen (15) days of CAI's request.

TIME OF COMMENCEMENT AND COMPLETION

- A. CAI shall commence on the project upon receipt of a fully executed contract.
- B. All work shall be complete within thirty (30) days of receipt of a fully executed contract and Patriot Assess Pro 5 CAMA data.

Payment shall be made to CAI within 30 days of invoicing. Said invoicing shall be done upon completion and delivery of the project as described herein.


