## Description:

The Fire Department is requesting the replacement of the current 2012 Ford F-350 pickup truck assigned to the shift commander. This truck serves a dual role: it provides reliable transportation for the shift commander during daily operations and responding to emergency calls. It also equipped to plow the fire station and clear driveways during emergencies. Maintaining clear access is essential to ensuring that ambulances and fire engines can reach residents in need without delay. Due to the age and condition of the vehicle, its reliability has diminished, increasing the risk of mechanical failure and potentially compromising emergency response. Replacing this vehicle will ensure continued operational readiness and the department's ability to provide uninterrupted service to the community.

## Benefits of Project and Impact if Not Completed:

### Benefits of the Project

Replacing the 2012 pickup truck will provide improved reliability for emergency response, increased operational efficiency, and enhanced plowing capabilities to ensure access during severe weather conditions. The new vehicle will also offer greater dependability, reduced maintenance requirements, and improved fuel efficiency, resulting in both short- and long-term cost savings.

### Implications of Not Completing the Project

If this project is not completed, the department faces an increased risk of vehicle failure, as the aging 2012 truck is more likely to experience mechanical breakdowns that could delay emergency response. Additionally, the town will incur higher long-term repair costs, reduced plowing effectiveness that may hinder emergency access, diminished safety features, and a greater likelihood of service interruptions due to vehicle downtime.

### Alternatives Considered (if any):

Both Ford and Chevy trucks were considered.
